They have spent the last 14 years rooted in LGBTQ+ political and community organizing ranging from LGBTQ+ policy work with state and local elected officials in Texas to HIV advocacy fighting against HIV Criminalization laws and for adequate public health funding and culturally competent prevention services. Most recently, Mike was elected as Vice Chair of the U.S. People Living with HIV Caucus. Mike is very proud of their role as former President of the Houston LGBTQ+ Political Caucus, growing the organization to be one of the most diverse and largest membership-driven LGBTQ+ civil rights organizations in the South, which held local elected officials accountable to the LGBTQ community while helping elect pro-LGBTQ+ candidates.

She has been fortunate to participate in nationally recognized projects such as PrEP in Black America, Gilead Sciences Champions of Change: A Celebration of Black Women Changemakers in HIV, Viiv Risk to Reasons national movement to retire the word "risk" associated with sexual health for women, the Florida Department of Health Sistas Organizing to Survive, a first-ever statewide campaign to address HIV among Black women, and initiatives to engage faith-based communities in the HIV response across the South. Leisha is a 2023 inductee into the University of Florida College of Health and Human Performance Hall of Fame.

Mrs. Garner is the Executive Director of the AIDS Services Coalition in Hattiesburg, MS. She was awarded a National Human Rights Award by the San Francisco Gay Men's Chorus in 2017 and was selected as one of the POZ 100 Women for her outstanding work in HIV/AIDS community. ## Dr. Athena Cross, DrPH | Vice President and Chief Program Officer | AIDS United





Their writing appears in the anthology Between Certain Death and a Possible Future: Queer Writing on Growing Up with the AIDS Crisis, and in 2022, POZ magazine named them one of the "100" most impactful HIV activists in the U.S. Passionate and dedicated, Edric continues to fight for justice at the intersections of health, race, and queer liberation.

## Xayla Gore | Co-Founder & Executive Director | My Sistah's House



Kayla is a nationally recognized advocate, published author, and nonprofit founder dedicated to advancing the rights and dignity of TLGBQ people, with a focus on Black and Brown transgender women. For decades, she has coordinated homeless services, led outreach, and championed housing justice, bodily autonomy, and racial equity. She has worked with leading social justice organizations including the Transgender Law Center, OUTMemphis, SONG, Black Lives Matter Memphis, Memphis Community Bail Fund, Planned Parenthood, and the Transgender Strategy Center. Kayla is the co-founder and Executive Director of My Sistah's House (MSH), a Black trans-led organization breaking down barriers to housing and homeownership for marginalized communities in the South. She leads the #TinyHouseProjectMSH, which has developed 11 homes—with more in progress—to provide permanent, affirming housing for Black and Brown trans women in Memphis.
